Brief Description of Your Project

- Project Goal: To rebuild marine fisheries stocks and catches through adoption of responsible fishing practices.
- The Coastal Resources Center (CRC) at The University of Rhode Island's Graduate School of Oceanography is the lead implementer of the SFMP and works in consortium with other international and local partners, including SNV, SSG-Advisors, Hen Mpoano, Friends of the Nation, CEWEFIA, DQF, DAA, and Spatial Solutions.

Key project activities:

IRI: Strengthen enabling environment for marine fisheries resource management. Policy reforms - Co-management, Fish Act, 3 CBMP (Densu, Pra and Ankobra) CLaT and NFMP.

IR 2: Science and Research applied to policy and management Strengthened information systems and science-informed decision-making through Scientific and Technical Working Group STWG). Capacity building for FC and UCC.

IR 3: Improved Constituencies and Political Will for Policy Reform and Sustainable Use Practices

Increased constituencies that provide the political and public support needed to rebuild fish stocks through a wide range of behavior change communications eg. advocacy campaigns conducted during major public events, F2F dialogues etc

IR 4:Applied Management Improved in Targeted Sites

Implementation of applied management initiatives for targeted fisheries ecosystems. VSLA, MSMEs trainings on post harvest value chain, rural loans for MSMEs. HFH,&P, BDS etc

Cross cutting Result Areas on Gender, Private Partnerships and Capacity Building:

Trainings on Gender, leadership for associations, FC and MOFAD, formed partnership with insurance companies such as BIMA, Millennium, UT life, Tigo, Vodafone and others for fisherfolks, building capacity of 10 GoG institutions and 9 CSOs in fisheries management.

Lessons Learned
